#### **LANDSCAPING QUESTION & ANSWER**

**QUESTION:** I have a Bradford Pear street tree on my property that has a green fungus growing on the tree bark. Is there a simple way to remove this unsightly fungus?

## **ANSWER:**

While there are many products on the market to remove the blue/green growth known as lichens, a quick easy way is to gently scrap off the lichens with a wire bristle brush. Although when doing so, I recommend that you use a mask to avoid inhaling any airborne particles from the process. Having said this, the growth of lichens is usually caused by environmental conditions, i.e., poor soil quality, water drainage, over pruning, etc. You may want to take the next step and identify the cause of the growth.

## **SPRINKLER SYSTEM WINTERIZATION**

**Reminder:** Please do not forget to conduct winterization of your sprinkler system. Each year we receive a few reports from homeowners who forgot and, as a result, have experienced frozen pipes, resulting in said pipes bursting.

#### **FALLEN LEAVES**



While Mother Nature provides us with such beauty as vibrant colored leaves on our trees, it also leaves us with a bit of a mess to clean up after the leaves have fallen. We want to take this opportunity

to remind you of the proper way to dispose of these leaves, which is the responsibility of each homeowner. Please refer to Declaration of Covenants – Article VI – Section 2(b).

### **FALL CHECKLIST**

In preparation of the fall season, you may find the following checklist helpful:

- ✓ Awnings For those homeowners who have an awning, ensure that the awning is properly secured.
- ✓ **Bushes** Prune and trim.
- ✓ Courtyard Drainage Grates For those homeowners who have courtyards behind their homes, ensure that all drainage grates are clear from overgrown grass.
- ✓ **Flowerbeds** Ensure that any plants located near your driveway and front entrance are protected to minimize any potential damage due to the snow removal process.

- ✓ **Gutters** Ensure that all your gutters are clear of leaves/debris.
- ✓ Ice Melt Ensure that you have a supply of ice melt on hand.
- ✓ Lawn Determine whether your lawn is in need of aeration/seeding and/or thatching. Please refer to the Heatherwood webpage under "Garden Tips" for info.
- ✓ **Outdoor Lights** Ensure that all outdoor lights are functional and bulbs are operative.
- ✓ **Patio Furniture** Ensure that any furniture or grills and covers left on your patio or porch over the winter are properly secured.
- ✓ **Sinkholes** For those homeowners who have a street storm drain located by their grass, check surrounding grass for sinkholes and fill-in as appropriate.
- ✓ **Sprinkler System** Conduct winterization of sprinkler system. When completed, ensure that all sprinkler heads have retrieved and are flush with the ground.
- ✓ Trees Prune, trim, and fertilize. For those trees that are in poor condition, you may want to consider deep root fertilization. Check lower tree branches to ensure that they do not interfere with pedestrians walking by your home; may need to be trimmed back.
- ✓ Water Hose Store for the winter.

#### **SNOW REMOVAL**

Please note the following information as it pertains to our Snow Removal Contract and our Governing Documents:

#### SNOW REMOVAL CONTRACT

- ➤ Snow removal shall be provided when snow accumulation reaches a minimum of two inches of snow.
- ➤ Amount of snow will be agreed upon by Contractor and Association. In case of a discrepancy, the National Weather Service will be used to determine amounts.
- > Snow removal shall begin within two hours after snow has completely stopped.
- Snow shall be removed from all sidewalks, driveways, driveway aprons, walkways to front door, front door landing, mailboxes, and fire hydrants. Please note that during heavier storms, if fire hydrants are blocked by Township plowing, clearance will not be included.
- Snow removal for single-family homes shall be completed as follows unless there are extenuating circumstances:
  - 2" 10" within six hours.
  - ❖ 10" or more within 12 hours.

## **GOVERNING DOCUMENTS**

- The Association will provide snow clearing from driveways, aprons, and walkways once accumulation reaches two inches or more.
- ➤ The homeowner will be responsible for snow clearing whenever accumulation is less than two inches.
- The homeowner will be responsible for removal of ice from driveways, walkways, aprons whenever ice occurs.
- The Board of Trustees MAY, by a two-thirds vote, direct Heatherwood's Landscaping Company to be prepared to spread ice melt on the common area sidewalks and street sidewalks just before or in the early stages of an ice storm (but this does not absolve the homeowner of responsibility as set forth in the bullet above. It should be noted that such a decision would incur substantial additional expense not covered in our current snow removal contract.)

#### **SNOW REMOVAL ISSUES**

#### **HOMEOWNER TIPS**

- Always keep "ice melt" on hand. It now comes in easy dispensable containers.
- Ensure that any outside items on patio are secured
- ➤ Protect plants located near driveways and front entrance to lessen any snow clearing damage to them.
- > During heavy storms, do not venture outside (excluding cases of emergency).
- > Set-up a "neighbor buddy" system—someone you can call if you are in need of help.

#### Blog

## Which Alcoholic Drink Was Originally Used To Treat Malaria?

#### **Answer: Gin and Tonic**

The first known treatment (and preventative) for malaria was quinine—a bitter substance derived from the bark of the cinchona tree. When British troops stationed in India balked at drinking a bitter dose of water laced with quinine, the British East India Company created a cocktail to help the medicine go down. This cocktail, a mixture of water, sugar, lime juice, and gin, became the beloved modern cocktail, the Gin and Tonic. If you're trying to fight off malaria with a trip to the bar, however, we'd suggest a stop by the pharmacist's first. Modern tonic water contains radically less quinine than its historical counterpart.

## The Mall Of America Is Principally Heated By?

#### **Answer: Body Heat**

The Mall of America, located in Bloomington, MN, is one of the largest malls in the world. So large and so frequently packed with visitors (40 million annually) in fact, that it has no central heating system.

Mall architects took into account the heat gained from the numerous skylights, the waste heat from the lighting, and—most important—the enormous amount of heat generated by the tens of thousands of shoppers in the facility at any given time. Shoppers generate so much extra heat that during peak shopping in the winter season (when temperatures dip into the single digits in Bloomington) the Mall actually runs the air conditioning system to keep the facility comfortably cool.

#### VETERANS DAY



## **History of Veterans Day...**

World War I – known at the time as "The Great War" – officially ended when the Treaty of Versailles was signed on June 28, 1919, in the Palace of Versailles outside the town of Versailles, France. However, fighting ceased seven months earlier when an armistice, or temporary cessation of hostilities, between the Allied nations and Germany went into effect on the eleventh hour of the eleventh day of the eleventh month. For that reason, November 11, 1918, is generally regarded as the end of "the war to end all wars."

In November 1919, President Wilson proclaimed November 11 as the first commemoration of Armistice day with the following words: "To us in America, the reflections of Armistice day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations."

The United States Congress officially recognized the end of World War I when it passed a concurrent resolution on June 4, 1926.

An Act (52 Stat. 351;5 U.S. Code, sec 87a) approved May 13, 1938, made the 11<sup>th</sup> of November in each year a legal holiday – a day to be dedicated to the cause of world peace and to be thereafter celebrated and known as "Armistice Day." Armistice day was primarily a day set aside to honor veterans of World War I, but in 1954, after World War II had required the greatest mobilization of soldiers, sailors, marines and airmen in the Nation's history; after American forces had fought aggression in Korea, the 83<sup>rd</sup> congress, at the urging of the veterans service organizations, amended the Act of 1938 by striking out the word "Armistice" and inserting in its place the word "Veterans." With the approval of this legislation (Public law 380) on June 1, 1954, November 11<sup>th</sup> became a day to honor American veterans of all wars.
