## **COMMUNITY CLEANUP DAY, JUNE 16, 2014**

We were happy to welcome all volunteers who gathered at the gazebo on June 16 to help in addressing the continuing problem we are experiencing with vacant homes. Grass is not fertilized; weeds grow with amazing



speed as time passes by. These four vacant homes are unsightly and needed attention, but the Board of Trustees is most reluctant to spend the Association fees of others on these properties. As our attorney had advised we are limited to weeding and cleaning the mulch beds, these volunteers came prepared with

shovels, brooms, weed whackers, and lots of enthusiasm. All homeowners should be grateful that the result was a vast improvement on the overall appearance of the properties. While we would be happier if the homes were occupied, once the process moves into the court system it is frustratingly slow. We receive monthly reports from our attorney's office at no charge, but there is little movement as a general rule.

Special thanks go out to those who helped on June 16 and those who continue to spread Preen, apply RoundUp, or even weed whack on a



regular basis: Joe and Marilyn Brennan, Rose Mary and George Colombo, Bill Dennis, Pat Donnelly, Ken Garner, Glenn and Esther Henson, Elaine Jones, Kathy Logan, Dona McKenney, Dave Murphy, Judy Parker, Carmen Popolo, Greg Rossini, and Evelyn Sass.

In addition to the Community Cleanup Day, volunteers continue to contribute time and effort in order to keep Heatherwood beautiful and, just as significantly, save the Association money to pay outsiders for such work. Greg Rossini has cleaned up fallen branches and other debris in the wooded area near the pump station, Bill Dennis has painted the entrance signs, replaced and/or repaired several handicap ramps, and saved the cost of a pest control contractor in order to remove wasp or bees nests in our common areas, Rose Mary and George Colombo and Kathy Logan cleaned the vinyl fence along County House Road, and Glenn and Esther Henson power washed the benches at the gazebo and cleaned the gazebo.

We are also still most fortunate to have our enthusiastic and efficient Mailing Committee, whose efforts save us

over \$70 each time a communication is delivered rather than mailed. While we have attempted to keep communication deliveries to a minimum, this committee truly saves us a considerable amount every year. The only mailings which are not delivered are ones we are required by



law to mail, such as the annual Budget and Budget Justification, votes for Board of Trustees elections, and documents regarding any changes in our Governing Documents.



Another form of communication is our amazing Website, created and maintained by our Webmaster Bill Taggart. There is a

fountain of information on it and you are encouraged to spend a bit of time occasionally to see what is happening there. This year Bill worked many patient hours with Rose Mary Colombo and Kathy Logan to achieve the goal of having a complete set of our Governing Documents on the website for easy review by our homeowners.

## RECYCLING

Homeowners are requested to please not overfill the recycling containers as some problems have arisen with plastic bottles and other debris being blown around the community and in some cases ending up in front of other homes, in the streets and/or into the storm drains. Your cooperation will be much appreciated.

#### **GOVERNING DOCUMENTS ON WEBSITE**

Our website now has available a current set of our Governing Documents, including the By-Laws and



Declaration of Covenants. They have been placed in a format which allows for changes to be made should they be necessary in the future. We have quite a

number of new homeowners who may not be familiar with some of the rules and restrictions in those documents and this now makes it very easy to review them without paging through a big binder or stack of loose papers. We have found in the past that new homeowners have been provided with a set of documents at closing but they have not been kept current by the previous homeowner. All are urged to take advantage of this new quick and easy way to review these documents.

#### **LEAF-PEEPING SEASON**

We all love the colorful trees in Heatherwood at this season, but it is time to remind homeowners that they are

responsible for bagging the leaves from the trees on their property. The Township will pick up the bagged leaves, but they should either be in clear bags or marked as yard waste. They should also be placed away



from regular trash cans to avoid any confusion. Our trees are getting bigger and we will all be facing disposing of our leaves.

Our Declaration of Covenants, Article VI, Section 2(b), states in part regarding leaves, "Lot owners will be responsible for the care and maintenance of any and all shrubs, flower beds, trees or other plantings on individual Lots. This responsibility is inclusive of bagging and proper disposal of any debris from said plantings, including but not limited to clippings, fallen leaves from trees, etc. Debris shall not be discarded in the streets or sewer drains via blower, broom or by any other means."

The Board of Trustees (BOT) has made every effort during the summer to skip cuttings whenever possible so we may extend the lawn cutting season as far into the fall as possible. Ideally this will result in the last cutting being in mid to late November, leaving what will hopefully be the major portion of leaf cleanup being done by the lawn contractor.

Please also be alert as to whether leaves from your property are being inadvertently blown onto the property of your neighbors. Heatherwood is a breezy community and there are areas where this has been a continuing problem which can be avoided if homeowners make a conscious effort to be aware if this is happening and take steps to avoid it or correct it if at all possible.

#### A BIT MORE ON YARD WASTE DISPOSAL

The Township will pick up brush, wood, and Christmas trees, but they have specific rules to be followed, just a few of which are quoted here:

"Brush and untreated wood are collected separately and recycled. Brush, such as tree limbs and branches, should be cut up into 4-foot sections and tied into manageable portions. Branches may also



be placed loose in containers under 50 lbs. Wood that has not been treated, such as plywood and 2 x 4's without stains or paint are collected with brush. These materials may be placed a few feet away from trash. Christmas trees are to be placed at the curb without plastic bags."

It is, of course, understood that such debris should be placed in front of your property and not in cul-de-sacs at the rear of your property.

#### WINTERIZATION OF SPRINKLER SYSTEMS

Just a reminder to homeowners not to forget the winterization of the sprinkler system. In the past we have heard about homeowners who forgot and then experienced frozen and bursting pipes.

## **SNOW REMOVAL - 2014**

Please note that our snow removal contract contains the following items:

Snow removal shall be provided when snow accumulation reaches a minimum of two inches.

Amount of snow will be agreed upon by the Contractor and the Association. In case of a question, the National Weather Service will be used to determine amounts.

Snow removal shall begin within two hours after snow has completely stopped.



Snow shall be removed from all sidewalks, driveways, driveway aprons, walkways to front door, front door landing, mailboxes, and fire hydrants.

Please note that during heavier storms, if fire hydrants are blocked by Township plowing, clearance will not be included.

Snow removal for single-family homes shall be completed as follows unless there are extenuating circumstances:

2" – 10" – within 6 hours 10" or more – within 12 hours

A gentle reminder to all: Stock up on your ice melt, as ice removal is a homeowner's responsibility. The BOT MAY, by a two-thirds vote, direct TLC to be prepared to spread ice melt on the common area sidewalks and street sidewalks just before or in the early stages of an ice storm, but this does not absolve the homeowner of responsibility when ice occurs. You should be aware that such a decision would incur substantial additional expense not covered in our snow removal contract and would seriously impact our snow removal budget.

## **REVISITING FLAGS AND SIGNS**

Every so often, it seems wise to revisit some of Heatherwood's lesser known regulations in an effort to continue to fulfill the responsibilities of the BOT and the Architectural Review Board (ARB). To that end, our Governing Documents indicate the following:

#### Flags -

- 1) Large decorative flags, other than the traditional American Flag, are prohibited. American Flags shall be of a size no larger than 3 ft. by 5 ft.
- 2) Small decorative flags/banners/plaques (not to exceed 24" by 24"), as part of the total allowed

ornaments, are permitted in front or side flower beds.

#### Signs -

- 1) One unlighted sign advertising a property for sale may be placed inside a window provided it does not exceed 30 inches by 48 inches overall.
- 2) One "For Sale" sign (not to exceed 24" by 24") advertising a property for sale is permitted on front lawn.
- 3) Open house signs are permitted only on the day of the open house. Sign shall be removed within two (2) hours after the open house is closed.
- 4) One Political sign (not to exceed 24" by 24") is permitted in front yard. Sign may be displayed two weeks prior to the election and be removed one week after the election.
- 5) No other sign may be erected without prior written approval of the BOT, with the exception of one security sign (*i.e.* alarm sign) front and rear of home. Sign in front of home shall be placed in flowerbed or attached to mailbox post. Sign in rear of home shall be placed in flowerbed.
- 6) Any of the aforementioned signs permitted on front lawns need to be removed on the day that lawn cutting transpires. Heatherwood's Landscaping Company is not responsible for any damage that may occur to signs left out on lawns.

#### **HOLIDAY DECORATION REMINDERS**

Our governing documents set forth the following guidelines for winter holiday decorations:

Definition of winter holidays includes Christmas, Hanukkah, and Kwanzaa

**Lights**, both blinking and steady, white or multicolored, are permitted on homes, garages, flowerbed shrubs, and trees. Spotlights to highlight ornaments are permitted on the lawn. Colored lights in garage lights are permitted.

**Decorations** are permitted on front doors, porches or front door landings, patios, garages, lawns, mailboxes, in flower/mulch, and tree mulch beds. All types of decorations are permitted, although discretion should be

used to ensure the high standards of Heatherwood's aesthetics. All decorations shall be secured properly. Decorations are permitted to go up one week prior to Thanksgiving but must be removed by January 31.

#### **ALWAYS LOOKING FOR VOLUNTEERS!**

We've experienced changes in some of our committees and encourage you to consider lending a hand. Some committees take very little



time, but help to serve our community in meaningful ways. We are presently looking for new members for the ARB, a most important committee, and the Garden Committee (which also needs a Chairman and continually outdoes itself in seeing to it that our entrances look beautiful in every season).

There are signup sheets for all committees at Open Meetings in April and October, but you may also call Target Management at any time to say you are ready, willing, and able to help.

Ebooks (or electronic books) and audiobooks can be downloaded to your Kindle or Nook devices. You can also read or listen to these books on your computer, smartphones or tablets. The Heggan Library, in conjunction with other South Jersey libraries, has books for download through Overdrive and offered at the South Jersey Audiobook and eBook Download Center. 
The grandchildren trick-or-treating took place the weekend before Halloween, with lots of fun for the grandchildren and homeowners alike.
