## **LANDSCAPING SEASON**

Once again we prepare for the landscapers, whose efforts will keep Heatherwood as beautiful as always. TLC has requested that homeowners be reminded to protect the areas around mailbox posts, backflow preventers, and any other cables near foundations that could be damaged if there is not a mulch bed or some other protection. This is something which is relatively easy to do and will certainly result in a lesser chance of damage.

You are reminded that as with snow removal, the process is as follows:

- 1) The homeowner will call the Management Office regarding the issue in question.
- 2) The Management Office will contact TLC.
- 3) The Management will email TLC with the same message, with a copy to the Board.
- 4) The Management Office will monitor the progress until the issue is resolved and will keep the Board of Trustees apprised.
- 5) As with snow removal, Board of Trustees members should not be contacted personally.
- 6) As with snow removal, homeowners should not interfere with workers in any way.

Please be advised that in an effort to help with over watering or under watering of your lawn, TLC has offered to assist Heatherwood homeowners throughout the summer season. They will help to explain the proper

amount of time to water with your sprinkler system and the setting of your irrigation timer. This offer does NOT include Irrigation Turn On. It will



certainly be helpful, however, to have guidance for areas such as the swales between homes, which historically have been problems due primarily to over watering.

For the information of those homeowners who do not



have computers and thus are unable to access this information through our website, please be advised the recommended colors for repainting doors and shutters are as follows:

PAINT MANUFACTURER: FINNAREN & HALEY

Black (02) Burgundy Red (27) Forest Green (28) Federal Brown (09) Tuxedo Gray (18) Wedgewood Blue (04)

It is probable other paint manufacturers may be able to duplicate these colors upon request; however, you are strongly encouraged to purchase colors as close as possible to these shades. Some shades are extremely bright and incompatible with the original colors of the builder. Fading of paint on doors and shutters is one of the items the ARB must inspect. Hopefully we will be able to keep Heatherwood looking its very best by keeping up with these important maintenance issues and using the recommended colors. Thank you for your cooperation in this regard.

## REMINDERS FOR THE COMING SPRING/SUMMER SEASONS

As we are well aware, Heatherwood has many open, windy areas and there are continuing problems with trash and other litter frequently blown into the ends of our courts



and various other spots in the common areas. In addition, homeowners often find trash from a block away on their property and this creates much understandable frustration on their part. There are also many instances where items are being blown into the storm drains and ultimately into some of the basins, where blockages occur, creating other basin problems.

We kindly ask that homeowners pay special attention to securing their trash and disposing of loose pieces of mail or any other litter being blown around the community. In previous years there have also been problems with barbeque and furniture covers being caught by the wind and blown about, which obviously can be prevented if they are properly secured. If each one of us cooperates in this endeavor we will be able to alleviate these issues, which are particularly troublesome for those whose homes are located in the areas where wind is a bigger problem than in others.

It may be helpful to refer to our Governing Documents regarding Trash: Exhibit E, Rules & Regulations, Section B. While our normal pickup day is Tuesday, please remember that holidays generally delay trash pickup by one day.

## CONTRACTOR AND **SECURITY ALARM SIGNS**

Just a reminder that if you have contractors doing work in your home or yard they are not permitted to post a sign on the lawn while the work is being done. This is a longstanding rule in Heatherwood, and the Board and ARB are required to enforce it.

Regarding security alarm signs, one may be placed in front and one in back of a home. The sign in front of the home is to be placed in the flowerbed or attached to the mailbox post. The sign in the rear of the home is to be placed in the flowerbed.

## **ENGINEERING STUDY**

We the Capital pleased to report Reserve/Engineering Study was conducted in early Spring by Consulting Engineer Services. At the time this newsletter is being published the final report has not yet been received. The Board of Trustees is reviewing the preliminary findings and will provide you with the full results in the near future.

## THANK YOU TO TARGET AND TLC

In December 2013 the Board of Trustees received the following message from Target Management:

"To show our appreciation for your continued business, we would like to donate a 5' Norway Spruce to be planted on your Association's common area. If your site cannot use the tree because of lack or space and/or aesthetics, Management will donate the tree on your Association's behalf. It will be the Association's responsibility to have their current landscaping company pick up and plant the tree on your site...." subsequently offered to pick up and plant the donated tree at no cost to Heatherwood. The planting will be accomplished this Spring. We thank both companies for their generosity in this regard.

## SOME UNWELCOME VISITORS



As most of you have undoubtedly seen, have been numerous deer Heatherwood during the winter and have feasted on shrubbery and trees in

both common areas and individual home lots. While we understand they are hungry and had to search for food during the unusually long and cold winter, many of us are going to have considerable expenses in replacing our plantings. Unfortunately, some homeowners have been observed putting food out for deer and other wildlife and this has made an already very serious problem worse. We strongly urge any homeowner doing so to cease this practice as we would certainly prefer not to have to address it with warnings and/or possibly fines. If anyone is observed feeding the wildlife, we will be forced to take action to protect the health, well-being and property of the other homeowners. All of us understand love for animals and it is simply unfortunate that there is a significant down side to this practice.

Along with the above, it has been reported that ticks are especially prevalent this season and it is hoped you will be cautious in your yards or when walking anywhere in the area with children or pets. New Jersey is notorious for its tick population, but the recent influx of deer in our area makes it even worse. Thank you in advance for your full cooperation.

Our muskrat visitors have either returned or new ones have replaced the ones removed last year. It appears this is going to be a continuing issue for the Board to address, not to mention additional expenses which were not an issue in previous years.

#### ARB SEASON

As you will note elsewhere in this newsletter, the ARB will be conducting its annual inspections in early Summer. It is important to remember that neither the ARB nor present or past

Boards of Trustees created the Heatherwood governing documents. They were created by the builder, J. S. Hovnanian, and have been used in other communities he has built. The rules and regulations have been carefully reviewed in the past, and over the years revisions and clarifications have been approved by the homeowners. The ARB members are all volunteers giving freely of their time and effort to complete their function as set forth in the governing documents.
