PRESIDENT'S MESSAGE

I feel as though 2021 has gone by in the blink of an eye! The projects announced in the Spring/Summer Newsletter have been completed and the Board of Trustees is already discussing new projects for 2022.

The most noteworthy projects completed in 2021 were the installation of the impressive new fountain and the installation of the pavers and plantings at the gazebo. These were major projects funded by our Capital Reserve account and had no impact on the monthly Association Fee.

The annual project to address the levelling of uneven sidewalks is planned again this year, as well as the replacement of two handicap mats which have deteriorated. These two projects address the safety of our homeowners who walk throughout our community.

As you know, this year we had three vacancies on the Board of Trustees. Ballots were mailed to all homeowners for the election. The procedures for this election have changed significantly from past elections. In July 2017, the State of New Jersey passed the Radburn Election Law, which focuses on voting rights and elections by Associations. Some of the significant requirements of this law are: voting must be anonymous, the ballots must include space for write-in candidates, ballots must be provided with the meeting notice, ballots must be counted publicly during an Open Meeting, a quorum of votes must be received for a valid election, and ballots must be made available to homeowners for inspection.

We received 107 votes and I thank all homeowners who took the time to vote in this election, with candidates Gary Bellotti, Linda Parks and Jim Sherry elected for two-year terms beginning at the conclusion of the Open Meeting on October 21,

OPEN MEETING OCTOBER 21, 2021



For the first time since the beginning of the Covid issue in early 2020 it was possible for us to return to the Washington Township Senior

Center for our Open Meeting. Following the Call to Order at 7:00 pm followed by the Pledge of Allegiance, President Rose Mary Colombo called attention to the Election Committee table located in front of the room, where election ballots would be counted in full view of those in attendance during the business portion of the meeting as required by the new Radburn Election Law.

Absent any request for reading, a motion was made to approve the Minutes of the May 13, 2021, Open Meeting, which was passed unanimously.

Treasurer Jim Sherry then presented the Financial Brief and Income & Expense Report as of August 2021, the most recent available at the time of the meeting. Upon hearing the current financial status of Heatherwood, there were no questions from those in attendance.

Prior to Jim's presentation of the proposed 2022 Budget and Budget Justification, Rose Mary announced that the Board of Trustees has voted to change management companies effective January 1, 2022 with First Service Residential for a two-year period.

Jim then followed with the proposed 2022 Budget Justification, explaining various adjustments made to cover an increase in our management company contract. With these changes in place, it has been determined there will be no increase in our monthly Association Fee of \$115 again this year, for the eighth year in a row. A question-and-answer period followed, after which, upon Motion, the Board of Trustees unanimously approved the 2022 Budget.

The Annual Report, Resolutions for the past year, and standard Annual Contracts for insurance policies were presented and approved, after which Election Committee Chairman Bill Taggart announced the results of the election as noted in the President's Message previously.

A brief question-and-answer period followed.

Rose Mary then thanked Diane Maitag, who has served as Heatherwood's Secretary for the past two years, for her excellent Minutes and her many substantive contributions at the monthly Work Sessions. She concluded by saying if there were additional vacancies on the Board in the future, it is hoped Diane would consider serving once again.

The Open Meeting was adjourned at 8:30 pm.

LANTERN FLY INFESTATION

our common areas sprayed, which was completed on October 20, 2021, while individual homeowners are responsible for addressing infestation of trees on their property.

Did you know about New Jersey's Register Ready? It is designed to help emergency responders locate and safely evacuate people who could find it difficult to help themselves in the event of a

major disaster such as a hurricane. Emergency responders need to know where you are and what special help you might need to assist in evacuating you quickly and safely.

Personal preparedness is at the heart of public safety and emergency response – before, during and after a disaster. Advance planning and preparedness are especially important for people with special needs, which includes anyone who may find it difficult to self-evacuate because of a physical or cognitive limitation, language barrier, or lack of transportation, particularly if family, friends, or caregivers are unavailable to help them during a crisis.

SEASONAL REMINDERS

SNOW REMOVAL



Snow will be removed from all sidewalks, driveways and driveway aprons, walkways to front doors, front door landing, mailboxes, and fire hydrants.

Please stock up on your ice melt, as ice removal is the homeowner's responsibility. The Board MAY, by a two-thirds vote, direct Marksmen to be prepared to spread ice

melt on the common area sidewalks and street sidewalks just before or in the early stages of an ice storm, but this does not absolve the homeowner of responsibility when ice occurs. You should be aware that such a decision would incur substantial additional expense not covered in our snow removal contract and would seriously impact our snow budget.

Until December 31, 2021, any issues regarding snow removal are to be called in to Target Property Manager Danielle Holmes at 856-988-8000, extension 311. If you reach an Answering Service, you should follow the prompts to leave a message. Target has its management staff check for messages on a frequent basis.

Please do not contact BOT members or Marksmen Landscaping directly, nor should you email the Heatherwood Communications email address or the Website. Complaints received through these venues will not be addressed.

Beginning January 1, 2022, contact information for First Service Residential will be provided.

HOLIDAY DECORATIONS



Our Governing Documents include the following guidelines for winter holiday decorations:

Lights, both blinking and steady, white, or multicolored, are permitted on homes, garages, flowerbed shrubs, and trees. Spotlights to highlight ornaments are permitted on the lawn. Colored lights in garage lights are permitted during this season.

Decorations are permitted on front doors, porches or front door landings, patios, garages, lawns, mailboxes, in flower and tree mulch beds. All types of decorations are permitted, although discretion should be used to ensure the high standards of Heatherwood's aesthetics. All decorations shall be properly secured. Decorations are permitted to go up one week prior to Thanksgiving, but must be removed by January 31. The definition of winter holidays includes Christmas, Hanukkah, and Kwanzaa.


